Did you promote DarkSky and its mission during your outreach programs/events? If so, describe:

We are always promoting Dark SKy and the mission of diminishing light polution in our programmes.

We are also also assisting other areas in Denmark in their aspiration for becoming Dark Sky areas.

There has been visits and talks for one aspiring dark sky place on the island of Fyn, advising on how to get started with the process, and answering questions from the municipality and village inhabitants.

Another delegation from the municipality of another part of Fyn visited, and was presented to the dark sky park concept, explained the biological and environmental effects, helped them observe the sky with telescopes and binoculars, and answered their many questions while gathered around a camp fire at night.

There is now an ongoing cooperation between Dark Sky Møn Guide, a researcher from the University of South Denmark, the municipality, and the village council, hopefully leading to an new additional dark sky place in Denmark.

We have some initiatives blending Dark Sky and culture /arts.Here at two

ongoing or planned, blending the arts and/or culture with dark skies? If so, describe:

### examples:

#### Event:

Dark Sky Winter Hike and Church Concert, February, 2, events, 95 participants

Dark, Food and Music events. Starting at the local Church with a twilight walk along the old church path under the expert Dark Sky guidance. Serving soup under the open sky and after that church twilight concert with flutist Chris Poole.

Cultural science projects about darkness:

A new project "Feel the Darkness" was launched running for the whole of 2024, funded by the regional cultural development fund "Kulturregion Storstrøm".

School children, their parents, and scout groups join the project and document light pollution levels and sources in their local area as well as feeling of darkness. The project covers 5 municipalities on 4 different islands in the region.

The results of the project will be:

- Measurements of light pollution levels across the region.
- Participants will learn about the night sky, and consequences of light pollution.
- Identification of sources of light pollution, suggestions for improvements, and communication with business owners and private owners about how they can improve their lighting
- Documentation of the participants feelings about darkness, by means of short video clips, interviews, texts, and images. These will be published continuously to media platforms.
- Publishing of a final assembly of all the participants contributions, in the form of a film.
- Publishing of the measurements on the "Globe at Night" platform. The goal is to create awareness of light pollution, and find ways to stop the increase. Another goal is to test the possibility of enrolling children and their parents in environmental sampling (citizen science).

Another application for funding is being submitted to the EU Interreg programme, for a similar project with participants from Denmark and Northern Germany.

We still find a huge interest in our Dark Sky events, and people have very positive reponses to particularly experiencing the Dark Sky and learning about it.

Briefly describe any efforts undertaken to reach new audiences. If this was not part of your efforts last year, describe what you plan to do to engage new visitors in the 2024 reporting period:

Dark Sky Ambassador Programme. March 2023, 25 partipants.
Dark sky education is part of the ambassador programme under our
UNESCO Biosphere Reserve ambassador programme. This entailed night
hike and atronomi training. This has resulted in several new Dark Sky
Ambassadors.

Dark Sky promotion and Counselling at larger meetings, 10th December 2023,

At our anual Biosphere Biosphere Christmas Market, Dark sky had its own table with information on the Dark Sky Park, and volunteers were all day telling people about light pollution and giving advice on what they themselves can do in order to protect the darkness in the area.

Have you worked with any external partners to promote the dark-sky movement within and outside of your Place's boundaries? If so, identify these partners and explain the result of this collaboration:

We are using multi-sector partnership approach in managing the Dark Sky Park & Dark Sky Community. This means that the work is anchored in a broad-based forum with Vordingborg Municipality (local government), House of Møn (the local tourism and commerce organization) work and civil society represented by volunteers and microentrepreneurs with strong Dark Sky expertise. This Dark Sky coordination committee meets on a regular basis and they collaborate on the action plan for initiatives and projects.

Were you awarded any grants or funding for projects during this reporting period? If yes, please describe: The regional authorities has funded a project that have resulted in a prospect for a larger Dark Sky attraction on Møn.

Are there any ongoing conservation and/or research programs at the site? If so, who runs them, and what are the goals?

No not at the moment. However, the previously mentioned cultural project which is underway is using a citizen science approach and there are some initial ongoing efforts in estasblishing a collaboration with some research institutions.

Briefly describe future plans (in 2023 and beyond) to engage with existing and new partners and how you will expand the dark-sky movement:

We are continually working on inviting new Dark Sky ambassadors through one-to-one contacts and through our ambassador programme. In the coming year the cultural Dark Sky project (mentioned previously) is also invisaged to lead to new relations and partnerships.

Stayed the same

Provide a brief description of how you will continue to manage "threats" over the next year: We will over the coming year work more determined in contacting particularly local companies in order to creating awareness and engagement in Dark Sky and tell them what they can do to assist with adressing these threats of light pollution. We will also continue to use our large events as a site for disseminating information to the local population on how to conserve the undisturbed darkness of the area.
